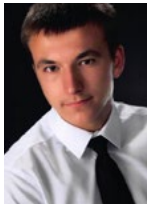
Marc met Suzanne Jenkins, of Greenville, North Carolina, in 1974. They were married in September of that same year and remained married the rest of his life.

Since his college studies were interrupted by the war, he completed part of his undergraduate coursework at the University of Wisconsin, Madison, and, though a member of the class of 1944, his Harvard degree was not awarded until 1946. Maxwell subsequently attended West Virginia University, where he joined the Phi Kappa Psi fraternity, before enrolling in Harvard Law School, from which he received his L.L.B. degree in



1949. He was admitted to the West Virginia Bar Association that same year and became an associate of the Clarksburg office of the law firm of Steptoe and Johnson in 1950. He began his own title insurance practice in 1958. Maxwell was a member of the West Virginia House of Delegates from Harrison County for two terms, from 1951 to 1956. He was delegate to the Democratic National Convention in 1956 (Adlai Stevenson) and in 1972 (George McGovern). He served as Clerk of the Harrison County Commission for twelve years until his election as judge to the Circuit Court of Harrison County in 1984, an office he held until 1992. He was a director of the Union National Bank and of its successor, Key Centurion Bankshares, from 1980 to 1988. A member of the Sons of the American Revolution, the Elks, the Jaycees, the Civitan, and the American Legion, in 1983, he was chosen as the West Virginia Italian Heritage Festival's Honorary Italian Man of the Year. Maxwell served as a founding member of the Cultural Foundation of Harrison County. As a member of its board of trustees, Maxwell played a pivotal role in the construction of the Clarksburg-Harrison Public Library, both convincing the City Council of the need for a new building and of the hiring of the internationally renowned architectural firm of Marcel Breuer. Maxwell further served as a founding member of the Cultural Foundation of Harrison County. As President of the Concerned Citizens of Harrison County, Maxwell was an advocate on behalf of the environment, speaking out forcefully about the consequences of surface mining. He made a special public protest at the Charleston State Capital in 1972 when mining applications were being made for areas within Watters Smith State Park. Along with his late wife, Susan Harnish Maxwell, the Judge was a great enthusiast of the arts, regularly attending classical music performances in Washington, D.C., New York, Pittsburgh, as well as Sarasota, Florida, where he spent many of his more recent winters. He was particularly passionate about opera and could often be found listening to the Metropolitan Opera's Saturday afternoon radio broadcasts on his Buckhannon Avenue home's front patio. He credited his regular reading of opera libretti for keeping up his French, Italian and German language skills, all of which he read and spoke with fluency. While a soldier in the U.S. Army, Maxwell was stationed at Letterkenny, Pennsylvania. As a result of his foreign language aptitude, he was placed in charge of Italian prisoners of war. Among his duties was accompanying some of these prisoners on weekend visits to their American relatives in New Jersey and surrounding areas. Despite his fluency in European languages, Judge Maxwell did not travel abroad until he was well into his 40s. But in following years he and his wife made regular trips to England, France, Germany, Austria or Italy, all part of well-planned pilgrimages to various museums and "great houses" to see first-hand the art and architecture Maxwell had studied in school. As serious a tourist as he was a reader, his personal collection of literature and art books, along with his music recordings, was extensive. As avid genealogist, Maxwell devoted a considerable part of his time to the care of his family's business concerns, as had his late father. His great-grandfather, Franklin Maxwell, of Doddridge County, served as State Senator from 1881 to 1884. Another Doddridge County ancestor, Lewis Maxwell, served in the Virginia House of Delegates (before West Virginia had become an independent state), as well in the United States Congress from 1827-1833. Judge Maxwell is survived by his brother, William B. Maxwell III of Charleston; two daughters, Clara Gibson Maxwell and Mary Maxwell Keller; a granddaughter, Saskia Maxwell Keller; two stepchildren, Michelle Gales Berry and Timothy William Gales; two step-granddaughters, Susan Gales and Kathleen Gales; and two great-step-grandchildren, Romeo Soto and Armani Gonzalez. He was lovingly cared for in his later years by Mary Katherine and Vickie Brown.

George B. Munroe

George B. Munroe, who led the copper mining and manufacturing company Phelps Dodge Corporation from 1969 to 1987, died painlessly and peacefully in his sleep on August 19. Munroe led Phelps Dodge through a difficult period for the domestic copper mining industry, as it struggled to meet growing competition from abroad and new environmental requirements at home. Munroe continued to increase the company's production as a new hydro-metallurgical process was developed to reduce the need for smelting in the production process and Phelps Dodge, which had been the third largest United States copper producer, emerged as the domestic industry leader and one of the largest producers in the world. Before joining Phelps Dodge, Munroe practiced law in New York as an associate with Cravath, Swain and Moore and Debevoise, Plimpton and McLean and worked in the Office of the U.S. High Commissioner for Germany in the early 1950's, serving first in Bonn as a lawyer and later in Nuremberg as a justice of the U.S. Court of Restitution Appeals of the Allied High Commission. Munroe was a trustee of Dartmouth College for 14 years and the chairman of its board for three years. He was also a trustee of the Metropolitan Museum of Art, serving on several of its committees for 25 years, and chairing the Museum's finance committee for 8 years. Other board memberships included the Henry Street Settlement, the YMCA of Greater New York and the Academy of Political Science, of which he was chairman for 10 years. He was a director of several major corporations, including the New York Life Insurance Company, the Manufacturers Hanover and Chemical banks, the Santa Fe Pacific Corporation, Manville Corporation and New York Times Company and was a Public Governor of the New York Stock Exchange. His service in the Navy during World War II included duty as a combat information center officer on the battleship Maryland in the Pacific. The Maryland took part in the invasion of Okinawa in 1945, where it survived damage from Kamikazi plane attacks. As a young man, Munroe was an outstanding basketball player on three Ivy League championship teams at Dartmouth and led Dartmouth to the national championship game of the N.C.A.A. tournament in 1942. That year, he led the Eastern Intercollegiate League in scoring and was named to several All-America Teams. Later, while attending Harvard Law School, he played in the professional league for the St. Louis Bombers and Boston Celtics. Munroe graduated from Dartmouth College and Harvard Law School with honors and from Oxford University in England where he was a Rhodes Scholar. Munroe is survived by his wife of more than 45 years, Elinor Bunin Munroe, an artist and award-winning film maker, and by two sons by a previous marriage, Ralph of Orange, Virginia and Taylor of Atenas, Costa Rica and a grandson, Zachary.

James A. Neilson Jr.

Dr. James 'Jim' Alexander Neilson, Jr. Born 19 April 1923 in Wheatland, WY, the only son of James Alexander Neilson, Sr. and Maude Lillian Nicholas, Jim spent the first four years of his life in Wheatland. His parents were teachers at Wheatland High School when they met. James Sr. had grown up in Sutherland, NE; but after his father's, Alec Neilson, untimely death, his mother, Agnes (Barr) took the small family back to her brother's, George Barr, in Philadelphia. There James Sr finished high school and went on to Penn State majoring in agriculture. Remembering the open country of the west, he returned to his sister's, Ina Franzene, and found a position teaching ag studies at Wheatland High School. Maude's father, James Nicholas, also had an untimely death in Cripple Creek, CO. Her mother Kathryn (Fobes) returned to her natal state of Iowa to support her small family by teaching. Maude went on to get her teaching credential at Cornell College. IA. After graduating, Maude found a position at Wheatland High School teaching English. Maude and Jim Sr were popular teachers. Jim Sr and Maude were married June 6, 1922 in Wheatland. Jim Jr.'s first memories were of the wind. He would go outside to play and have to hunker down behind a snowdrift to escape the wind and stinging sand. After 6 years of the wind, ca 1927, his mother stated they were leaving. Jim Sr. decided to take the family, which now included a daughter Jean, to California. Jim Jr remembers the day they, drove to the Cheyenne railroad station in his uncle's, Ben Franzien, touring car. There were only cow tracks for roads; topping a windswept ridge, Ben stopped, declaring it time for coffee and sandwiches. Arriving at the station, arrangements were made to go to Glendale, CA to stay with his grandmother, Kathryn, until Jim Sr could join them at the end of the school year. Relocating to California, Jim Sr. found a job as an agriculture program troubleshooter in high schools for the State of California. He would go into a high school and correct the problems in the ag program; but it meant moving every couple of years. The family lived in Upper Lake, Oceanside, and Galt. Tiring of constantly moving and wanting to farm, Jim Sr leased a farm in Woodland, CA and relocated the family there. It was here that Jim Jr began his agricultural pursuits. His dad got him started with a poultry project for FFA. A bit later his dad got a chance to buy his own ranch on the Sacramento River in the Sutter Basin; banks were financing, if he would only take over farming lands held in foreclosure. It was about 1933 in the depths of the farm depression. This totally changed the direction of Jim Jr's life. He spent about the next 30 years on the Riverlane Ranch. Jim Jr. worked with his dad on the ranch helping with haying and irrigating, he had FFA projects in sheep, hogs, rabbits, poultry, and crops. One of his every day chores was to do the morning milking before school. He loved high school, and because he was tall - 6'5" - he played basketball. One of his high school teachers convinced him to go on to University of California, Davis; which he did. There he majored in plant pathology. While at Davis, he was in the UC Davis Secret Society for the Good of the University, editor of the UCD newspaper, and Cal Club. Because it was the war years, Davis was turned over to the Signal Corps at the end of Jim's sophomore year and the students were transferred to Cal Berkeley. In his junior year at Cal he joined the secret Golden Bear Society, which was the counterpart of UCD Sword and Sandals. Both were highbrow groups with many ideas for policy and activities. He also belonged to the Phi Kappa Psi

fraternity. He belonged to ROTC and went on to Camp Roberts in California for basic training the end of his junior year. He thought basic training was a vacation compared to ranch work. However, he came down with a major sinus infection, and being before penicillin, it was a serious medical condition. The medical officer gave him the choice of army office work or returning to the ranch to help his dad. Since farm help was hard to find, Jim chose to return to the ranch. He helped his dad for two years. In 1946, the family decided it would be best for him to finish his degree so he returned to Cal. During this time, he met Georgiana Gamble, who became his first wife on November 15, 1947, in Woodland, CA. After graduating from UCB in 1946 with a BS in Plant Pathology, he began graduate school in the fall. However, with the accidental death of his father in March 1947, another major turning point in his life was reached. He left school to return home and take over the management of the ranch with his mother. The first thing he did was to sell off the milking cows. Over the years he and his mother continued with ranch improvements, leveling fields, improving irrigation, trying new crops, Suffolk sheep and Poland China hogs. Also, six children were born: Georgiana Jean, Laura Louise, Heather Diane, Bruce Angus, Baby boy, and Ian Andrew. During the years at the ranch, he and Georgie were active in St. Luke's Episcopal Church in Woodland. Jim was also active in Lion's Club, becoming the scout master for the troop the club sponsored. He started with 6 boys and after six months the troop had about 35 boys. He was involved in scouting before he had boys of his own and he remained active in scouting intermittently up through the 1990s. All his sons attained Life or Eagle Rank. When Maude stated she wanted to retire and sell the ranch about 1959, another turning point in Jim's life was reached. He decided to return to Davis and finish his graduate degrees before the ranch was sold. For several years he commuted between the ranch and Davis managing the ranch and working on his Masters. In 1961 he received his master's and continued on for his PhD. That same year Maude had an offer for the ranch; selling it she and Jim and family moved to Davis. Jim finished his PhD in Plant Ecology, Jan 1964. In 1964, plant ecology was a new, exciting field of study. Jim studied under some of the most influential scientists in the field - Drs. Major, Stebbins, Esau, Robbins and Weir. After graduation he moved the family to Yellow Springs, Ohio taking first a position at Wilberforce College and then at Antioch College, while not really liking the East, one of the greatest adventures of his life happened while he was there. He was offered the chance to do research in the Yukon Territory with the Arctic Institute for the summers of 1967 and 1968. For a guy that loved the outdoors - hiking, botanizing, being on his own - it was a dream come true. He spent two summers studying the vegetation, discovering one new species and extending the known range of a few more. Returning to Ohio, he decided to move back west. About 1968, the University of California, Davis undertook integrating the research of several departments and formed the Institute of Ecology. In 1969, Jim obtained a position as an assistant research ecologist. At first, he was hired to coordinate the field research projects of Dr. Charles Goldman; then he worked on revegetation studies of his own, developing a Plant Species Check list for the Tahoe Basin, working out revegetation methods for decomposed granitic soils, and mapping the plant communities in the basin. While doing the research, he also did environmental consulting on the side. As the research project wound down, Jim expanded his consulting. Finally, in 1972, he went on his own and formed the firm Ecoview Environmental Consultants. At first the firm did environmental impact studies on any type of projects - residential, wineries, mining, and geothermal. It quickly became apparent that geothermal were the most challenging and interesting projects. For the next 15 years, geothermal development was a major part of Jim's life. While at Davis, Jim had met Dianne McQuaid; they were married in Sept. 1973, Chatsworth, CA. Settling in Napa, CA, because it was only an hour drive from all the consulting project areas, Jim put together a team of experts that could be contracted with to assess and suggest mitigations for the development of the geothermal field then being developed in the Maycamas Mountains of Sonoma County, CA. His firm rapidly gained a reputation among county planners, industry representatives, and

environmentalists as being knowledgeable, practical, and impartial in his assessments and mitigations of impacts. The firm's reports helped develop the standards and content expected in a good environmental impact report. To facilitate needed vegetation studies, Jim authored the 'Flora of the Mayacamas Mountains'. During their life at Napa, Jim and Dianne remodeled their home, landscaped and gardened intensively their 3/4 of an acre, raising chickens, bees, lambs, rabbits, fruits and vegetables – practically their entire food supply. In the mid 1990s, he decided to pursue a career in academia after a lengthy and successful career in industry, both as an employee of a major corporation and as owner and president of several small consulting companies. From 2013-2017, Riley served as ECE's associate chair for graduate affairs.

During his career in ECE, Riley had an outstanding reputation in teaching programming techniques, computer networking, and engineering software design. He was recognized with the Richard M. Bass/Eta Kappa Nu Outstanding Teacher Award in 2008, and he received the Georgia Tech W. Roane Beard Outstanding Teacher Award in 2009. Over the years, Riley was involved with K-12 outreach activities, including the ECE HOT Days camp for high school students, and was honored for this work with the ECE Outreach Award in 2010.

Riley's research focused on creating more efficient methods and tools for simulation of both wired and wireless computer networks. He also worked in Internet measurement methods, Internet routing protocols, and development of numerical methods for monitoring and adapting finite queue sizes in packet-based networks. Riley also worked on the application of large-scale simulation methods towards the simulation-based design and analysis of multi-core systems and on-chip networks. Always highly involved in the larger Georgia Tech community, Riley served as the chair of the Georgia Tech Executive Board, in the Academic Senate, and on the Institute Undergraduate Curriculum Committee for six years, with two of those years spent as its chair. He also led a campus

wide international plan task force in 2011.

Riley is survived by his wife, Kris Nagel, who is an academic professional in ECE. He completed his residency in Neurology at The University of Iowa from 1964-1967. He served in the United States Navy at Great Lakes Naval Station from 1967 to 1969. He never saw combat but joked throughout his life that he had heroically "stormed the beaches of Lake Michigan." In the summer of 1960, while working at Chicago's Museum of Science and Industry, he met Linda Clare Reed, the most beautiful girl on the Southside of Chicago (though he would consistently say throughout his life that it was her intelligence - her mind - that really swept him off of his feet). This meeting marked the beginning of a 44-year relationship, one characterized by deep respect, abiding friendship, loving compassion, shared interests, endless conversation, and ridiculous amounts of laughter and silliness. Pete and Linda were married on the 8th of June 1963, and within the next six years, had daughters Julie, Brooke, and Kristin. In 1969, the family moved to Austin, and within the next eight years, sons Alan and Mark and daughter Erin were added to the family. After a year at Austin Diagnostic Clinic, Pete, along with his friend and colleague J. Douglas Hudson, M.D., founded the Austin Neurological Clinic in 1970. For the next 32 years, he earned the love and respect of countless thousands of patients and colleagues in the Austin area, all of whom came to appreciate his skill, his kindness, his humor, and his passionate devotion to the practice of outstanding medicine. He was very involved in

the Austin community, and derived great satisfaction from these activities. He served on the Austin Community College Board of Trustees from 1980 to 1982, and on the Austin Independent School District Board of Trustees from 1980 to 1986. In 1978, he co-founded the Northwest Austin Kickball League, which is now one of the largest, most successful kickball leagues in the state. His role in creating this league and seeing it continue to thrive throughout the years brought him lasting and significant joy. He was a man of innumerable interests. He was a superb athlete, and loved playing sports of all kinds, particularly football, tennis, and racquetball. He was a rabid sports fan, faithfully cheering on his Chicago White Sox, Chicago Bulls, and Dallas Cowboys. He was a master gardener, and over the years created many exquisite gardens, all of which overflowed with beauty, color, and creativity. He was an avid bird-watcher and could identify virtually any bird by either its color or its song. He loved history and politics, and continually sought to educate himself on such matters. He appreciated great music and great art and passed this appreciation on to all of us. He was a great conversationalist, and there wasn't a topic in the world that you couldn't discuss with him. He was endlessly fascinating and fascinated. But it was his role as husband, father, and grandfather in which he shined the brightest and found the greatest delight. His family was everything to him, and his love for us was, quite simply, huge. There were six of us, but he forged a unique bond with each of us and took a passionate interest in all that we did. He was our teacher, our coach, our playmate, our example, our provider, our protector. He was selfless, he was tireless, he was hilarious, he was a BLAST. He played ball with us, helped us with homework, cheered us on, took us on adventures. He loved our mother so well, and treated her with such respect, adoration, and appreciation. When she became ill in the 90's, he remained so devoted to her, and lived out so perfectly the vow of "in sickness and in health." In his final moments, the words that kept coming to us were, "You were the greatest Dad a child could ever have asked for." He was a dedicated Pompa to all of his grandchildren, and they ADORED him. In his later years, his almost every thought was about them. He couldn't wait to hear news about them, and he spent countless hours visiting with them, writing them letters, helping them with school assignments, and of course, looking for the perfect presents for them. What unspeakable joy they brought him! In December of 2002, after 65 years of near-perfect health, he suffered a massive stroke that left him quadriparetic. Initially, he could not speak, swallow, or move, and he was not given much of a chance to live. Over the course of the next eight and a half years, he would defy every odd at every turn. He regained his speech and swallowing, as well as movement in his right arm and hand, which opened up a whole world for him. His relentlessly positive attitude and his refusal to live a sedentary life made his last several years full and abundant! He got up in his wheelchair every day, went on numerous outings every week, maintained many of his hobbies and interests, and continued to fully engage with family and friends. He did it all with amazing strength and fortitude. The family wishes to express its deep thanks to the countless physicians, nurses, and various medical professionals who helped care for him for these last eight and a half years. We offer special thanks to his very own angels on earth - his at-home caretakers Damita King and Kathy Carmon. No other single individual or thing added more to Pete's quality of life than Damita and Kathy. They will be family forever, and we will be eternally grateful for the beautiful and selfless way that they cared for him. Finally, we thank the extraordinary Dr. Bruce Bowers of Medical City Hospital in Dallas, Texas. Dr. Bowers performed life-saving surgery on Pete in April of 2010, and in doing so, added 14 precious months to his life. We are so thankful that he believed in Pete, and that he practiced such aggressive, courageous, life-extending medicine. Pete was preceded in death by his beloved wife of 41 years, Linda Clare Reed Werner, his sister, Stephanie Werner, his mother, Teresa Werner, and his father, Alfred Werner. He is survived by his daughter Julie Frisbie, her partner, Barbara Reilly, and their children, Chandler, Darby, Chris, and Shelby, daughter Brooke Yura, her husband Tom, and their children, Rachel and Christopher, daughter Kristin Werner, son Alan Werner, son Mark Werner, his wife Christy, and their children, Camden and Kinsley,
